The Southeastern Oklahoma Continuum of Care (CoC) is accepting applications for the Continuum of Care Builds Notice of Funding Opportunity FR-6800-N-25A through the U.S. Department of Housing and Urban Development (HUD). The CoC may only submit one non-tribal and one tribal CoC Builds application. **The CoC is open to and will consider applications from organizations that have not previously received CoC Program funding.**

The U.S. Department of Housing and Urban Development (HUD) HUD's [Strategic Plan for Fiscal Years \(FY\) 2022-2026](#) sets the direction and focus of its programs and staff to create strong, sustainable, inclusive communities and quality, affordable homes for all. In the 2024 CoC Builds NOFO, HUD will pursue two overarching priorities from its [Strategic Plan](#) focused on increasing equity and improving the customer experience across all HUD programs.
