

KI BOIS has IRS-certified preparers to assist you in e-filing your Federal AND Oklahoma state taxes. The following Income Tax preparation sites will be available February 1st - April 15th, 2023, for your 2022 Income Taxes.

Requirements

It is REQUIRED for anyone taking advantage of this service to provide the following, or we will be unable to process your return.

- ✓ Photo identification of Taxpayer or Spouse
- ✓ Social Security card for <u>EACH</u> family member named on the return
- ✓ Proof of Health Insurance Coverage (Form 1095) or Exemption Form (Form 8965)
- A voided check or letter from the bank for direct deposit
- ✓ All W-2's, 1099's and 1098's (Bank Interest & Royalties) received in 2022

KI BOIS WILL NOT prepare the following returns:

- Civil Service Retirement (CSA-1099's)
- Stocks
- Capital Gains/Losses
- Cancellation of Debt
- •Health Savings Accounts (HSA)
- Clergy
- •Any other return that is deemed out of scope by each county office.
